PRIVACY POLICY

At **PADARIA GOMES**, we consider your privacy to be a very serious matter. We are committed to optimize your experience within our website and social media platforms, in a secure environment. It is our policy to treat your personal data with discretion and to protect them. This Privacy Policy explains how we collect, protect, use and share information about you online and offline, with the hope of increasing your confidence in **PADARIA GOMES** and improve your experience with us.

Please note that this Privacy Policy applies to information collected by **PADARIA GOMES** only and does not extend to information you may have submitted on other sites or social platforms managed by other entities or organizations to which we may refer. 4. COOKIES
